
## 1. Order

# Frequently Asked Questions

## **Is the Swirl Gift Card tax-free for employees?**

**Yes. Swirl Gift Cards are fully compliant with the Irish Revenue Small Benefit Exemption scheme, allowing companies to give up to €1,500 tax-free per employee per year.**

## **How long does it take to process and dispatch the cards?**

**Cards are typically dispatched within 1–2 working days of receipt of funds. Delivery can be made in bulk to HR or direct to employees.**

## **Are there any fees for employees using the card?**

**No. There are no additional fees for using the card online or in-store. The full card balance is available to spend.**

## **Where can employees use the Swirl Gift Card?**

**Anywhere Mastercard is accepted – in-store, online, and internationally. There are no vendor restrictions.**

## **Can I place bulk orders for multiple employees?**

**Yes. Swirl supports bulk ordering for teams of all sizes and provides secure delivery options to either a central office or directly to individual recipients.**

## **Do employees need to register or activate their card?**

**Yes, cards require quick online activation via the Swirl app or website, which also allows users to manage balances and transactions.**

## **Is there a minimum or maximum order value?**

**There is no minimum order, and companies can order any quantity. The maximum value per card under the tax-free scheme is €1,500.**

## **What if a card is lost or stolen?**

**The card can be frozen or replaced using the Swirl app or customer support. Balance protection is available once the card is registered.**

## **How do we track our order or get support?**

**Our corporate support team is available via phone and email. We also provide real-time order updates and dedicated assistance for repeat orders or annual reward cycles.**
